**Committee/ Department Reports:** October financials for the Fire Department were approved.

**Financials:** Councilman Malott motioned to approved the August 2023 financials. Councilwoman Traxler seconded the motion. All in favor, motion passed.

**Administrative:** Councilman Taylor motioned to approved the October 2, 2023 minutes as presented. Councilman Monson seconded the motion. All in favor, motion passed.

Councilman Taylor motioned to hire Joel Geiger to install a new garage door opener at the city garage. The price of the opener will be \$719.00 and the price of the installation will be \$450.00. Councilman Monson seconded the motion. All in favor, motion passed.

**Code Enforcement Report:** There have been two violation letters sent out, one for 209 Main Street and one for 415 Golden Gate Street.

Kelly Fuenmeler has agreed to be the city judge but the council would like more clarification on if she will wave her monthly fee if there is no need for court to be held. The council also asked that a contract be drawn up by the city attorney before she is appointed as the city judge.

**City Clerk Report:** Rainbow Communications was contacted about getting dead trees removed from their property. We can expect to see them removed within the month of November.

An employee from KDHE met with City Clerk Macy Bryant on Friday, November 3, 2023 to discuss water and sewer rates. He will be sending a letter with suggestions on how to move forward with this process.
